Counselors turned in their 2011-12 enrollment forms. Erin asked the counselors to hold off on any changes until after spring break.

Reporting changes will help get all enrollments organized and get students placed in programs. Erin thanked everyone for all their hard work in getting students signed up for Central Nine programs.

Erin explained the program sequence spreadsheets. The program sequence chart per school was passed out for counselors to look over and verified that the CTE courses that each school is correct.

Counselors were asked to e-mail Ms. Donaldson or Erin to confirm the information is correct.

Erin passed out and explained two opportunities for students. The first opportunity is "Fearless Females" Erin explained this is a great opportunity for girls who are interested in engineering. The other opportunity is IUPUI school of Informatics Summer program. This is an opportunity for students who are interested in video game design and graphic design.

Erin discussed Ivy Tech's Summer Bridge Program that is available to current Central Nine students as well as any students from the sending schools that have participated in CTE classes. The program will provide a chance for students to take up to six credit hours of college credit at no cost to the students. The classes that Central Nine will be offering is CINS 101 - Intro to Micro Computers and IVYT 120 - Ivy Tech Life Skills class. Erin mentioned that she will keep the counselors posted as more information becomes available.

Erin shared with the counselors that Central Nine is looking at offering the ASVAB for all students starting in the fall of 2011. Erin explained the final decision is contingent upon the Business and Industry committee discussing the ASVAB test with the teachers association.

Erin invited Elizabeth Lerch from Conexus Indiana to share with counselors the importance of promoting advanced manufacturing with their students.
